Unit Trust of India Investment Advisory Services Limited, a union government company, has initiated its voluntary liquidation as per Section 59 of the Insolvency & Bankruptcy Code, 2016 (Code) read with the Insolvency and Bankruptcy Board of India (Voluntary Liquidation Process) Regulations, 2017 (VL Regulations) and accordingly I have been appointed as the Liquidator of the Company.

The initiation of the voluntary liquidation process of the Company and my appointment as the Liquidator is pursuant to the requisite resolutions passed by the shareholders of the Company in the Extra-Ordinary General Meeting held on December 16, 2021 in accordance with Section 59(3)(c)(i) of the Code. Furthermore, the company does not have any debt.

Following the above, the Company is under voluntary liquidation with effect from December 16, 2021 in accordance with Regulations 3(3) of the Voluntary Liquidation Regulations and I am exercising the powers of the liquidator as provided for under the provisions of the Code read with the Voluntary Liquidation Regulations, and any other laws as may be applicable for the time being in force in order to effectively liquidate the Company.

Pursuant to my appointment as the Liquidator of the Company, I have published a Public Announcement dated December 20, 2021 calling upon stakeholders to submit their claims. The Public Announcement was done in accordance with Regulation 14 of the VL regulations, as per which the last date of submission of claims was January 15, 2022 (i.e., 30 days of the Liquidation Commencement Date).

The communications for initiation of Voluntary Liquidation, the appointment of the Liquidator and the consequent public announcement calling upon the stakeholders to submit their claims was also sent to the existing employees of the Company, shareholders of the Company and various statutory and licensing authorities engaged with the Company. The said intimation has also been duly shared with the Registrar of Companies and the Insolvency & Bankruptcy Board of India. The intimation has also been uploaded on the website of the Company. Further, a notice intimating the commencement of Voluntary Liquidation dated July 14, 2021 has also been issued to the Income tax Department under Section 178(1) of the Income Tax Act, 1961.

Pursuant to the public announcement dated December 20, 2021 calling upon the stakeholders to submit their claims, I have received claims from various stakeholders which have been verified by me and accordingly, on the basis of proofs of claims submitted till January 15, 2022 and in accordance with Regulation 30 of the VL Regulations, the below stated List of Stakeholders has been prepared.
